Kadynce Sanders: SA #3 Feedback

Here are some benchmarks or goals that you should keep in mind as you create your Source Analyses. I will use these as I provide feedback and evaluation. I'm looking not only at how you perform on any one individual Source Analysis, but also how you demonstrate growth in this area across the semester.

Comments on Source Analysis #3:

Kadynce,

Thanks for including all of the assigned sources—not everyone was able to do this, so I appreciate it. Your summaries of both sites are okay, but for the "Plant Knowledge" article, I'd encourage a bit more detail in your summary. Perhaps include one or two examples of how plant knowledge and names promoted survival (nutrition) and how some of those names survive to today. Maybe also include one or two things that Robbie and Ashley have done (via their professional profiles) that can connect to the work we will be doing. I know that some of this information only started to emerge after we met with Robbie, but these are aspects of future SA's that you can work on.

I like the takeaways for both sources. I would encourage you to deepend this aspect of your SA's going forward, especially as we become more familiar with the goals, challenges, and activities with the Garden.

I would recommend that you create a distinct source analysis for each of the assigned readings/sites, and then include a takeaway paragraph at the end that links everything together and links the information that you learned more specifically to the Gardens. Right now, you have the information from each source, but it is all kind of lumped together in long and difficult-to-follow paragraphs.

I also recommend that you start putting a fully formatted bibliography for multiple sources at the end of the SA. You can use Zotero (zbib.org) to format all kinds of readings, including journal articles and websites.
